2018 STATE CENTRAL COMMITTEE NOMINATION FORM RULES (2018 ByLaws)

Pursuant to Article V, Section 2B. - The nomination paper of a candidate for Party Chairperson, National Committeeman and National Committeewoman shall be signed by not less than ten (10) certified members of the Democratic Party of Hawai'i from at least two (2) County Organizations. Signatures may be electronic.

Pursuant to Article V, Section 2C. - The nomination paper of a candidate for Youth Representative shall be signed by not less than ten (10) certified members of the Democratic Party of Hawai'i, all of whom are members of the Party who are thirty-five (35) years of age or younger.

Pursuant to Article V, Section 2D. - The nomination paper of a candidate for a State Central Committee member shall be signed by not less than five (5) certified members of the Party from the nominee's Senatorial District or Caucuses.

Pursuant to Article V, Section 2E. - The nomination paper for a State Central Committee member filing as a County Representative shall be signed by not less than five (5) certified members of the Party from the nominee's County.

All of the above mentioned nominees are elected at the Democratic State Convention, except for the County Representative who is elected from the respective County Convention.
